Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

How?	All financial companies need to share Customers personal information to run their everyday business. In the section below, we list the reasons financial companies can share their Customers personal information; the reasons UnlimitedMortgageLendingllc chooses to share; and whether you can limit this sharing.

What we do

How does **unlimitedmortgagelendingllc** protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

We are strictly digital and use rotating passwords, VPNs, and email encryptions.

How does **unlimitedmortgagelendingllc** collect my personal information?

We collect your personal information, for example, when you

- Apply for a loan or Provide account information
- Provide your mortgage info or Provide employment info
- Provide income information

We also collect your personal information from others, such as credit bureaus, affiliates and other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See **Other Important Information** below under **State Law**.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Unlimited Mortgage Lending, LLC has no Affiliates

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- Unlimited Mortgage Lending, LLC does not share with nonaffiliates so they can market to you.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- Unlimited Mortgage Lending, LLC does not jointly market.
